UPDATE – NASSAU OFFICE

The Prime Minister of The Commonwealth of the Bahamas announced a new two-week lockdown following the increase of cases in the country. This lockdown might well be extended following the two weeks announced, depending on how the number of cases evolve.

Overnight EMERGENCY POWERS (COVID 19 PANDEMIC) (LOCKDOWN) ORDER, 2020 was issued.

Under the order International Banks and Trust Companies may operate Monday to Fridays between the hours of 9am and 5pm with a maximum of ten staff members. We will operate with limited members of staff within our premises to limit health risk exposure and continue our enhanced social distancing. Therefore, most of our staff will be operating remotely and a limited banking team will operate within our office.

Our offices will continue closed for visitors and packages during this time.

Connecting virtually: With most of our team members working remotely, mainly from home, all remain readily available and will continue to be, via specific phone numbers and e-mail addresses, able to support and service any requirements.

We continue monitoring Government guidance in The Bahamas and our other locations, and adapting to any relevant local requirements.

Our other office locations: Montevideo, San Juan, Cayman and Hong Kong remain open and operational at this time.
